# Mythbusting

From a local paper article on the rates debacle

The council executive recommended prioritising projects like the Waiari water treatment plant, the Te Maunga waste water treatment plant, the Harington Street carpark,

the kerbside rubbish collection and road renewals.

It said the adage that 'growth pays for growth' was no longer true, partly because of long pay-back periods. This was backed by an Infrastructure New Zealand report that, nationally, it cost councils \$50,000 to pay for the pipes and roads for every new house.

The meeting heard that the lack of housing and infrastructure in Tauranga was already holding back growth.

Public consultation for the draft annual plan is expected to start on March 25.

Why isn't the carpark poor design work and problems covered under consultant's insurance.

Waste water upgrade to cover new gib board factory. Surely this is their cost. Does heavy industry have a place in Tauranga?

No need to have a ratepayer funded kerbside pickup

If this is true, then for every new section \$50,000 dollars goes on the consolidated debt and the ratepayers perpetually pay the interest on this and never repay the principal.

No more growth.

More housing and infrastructure drives us deeper into debt.

Will anyone listen if we submit – no way.



## **Mythbusting Answer**

More detail for \$26 million waste water upgrade for the new industrial development. Thankyou to Steve for taking the question to council and providing their answer.

"Costs relate to the Tauriko Business Estate, future industrial extension south of Belk Road and Tauriko West.

Developers in the Belk Road and Tauriko West areas will be required to fund all internal infrastructure within these growth areas, infrastructure costs to the boundary of these growth areas (including these costs) *are debt funded by TCC and recovered through development contributions*.

The scale of these costs and multiple landowners and developers that they serve make it difficult to consider developer forward funding."

The issue being, the debt to provide infrastructure to the boundary sits on TCC's balance sheet until the last \$ in development contributions is paid in say 20 years."

Therefore we need more revenue (code for rates) to stay within out net debt to revenue ratio of 250%.

So the **Bank of the Ratepayer** will pay the for all this development, including all interest costs for 20 years at no charge to the developer and he only pays at 2020 costs.

A better solution, the developer borrows the money and he pays the council up front for the works, he also pays the interest costs.

Also as we know construction costs escalate over the years, so the council should charges the price of the works plus to cover the increased costs. Refund any difference in 20 years time.

Why does the Bank of the Ratepayer have to pay out all the time? This is our money being wasted by gross negligence in the bowels of the council. Only takes a simple computer program to manage.

Same for large scale property developments. This council is too development orientated.
